Disaster Airlift Response Team Update

Carol Munch provided an update regarding an event that the Disaster Airlift Response Team will hold on April 26, 2025, from 10:00 to 14:00 Pacific Time. Dignitaries from various places in California will visit airports in neighboring cities to form closer relationships to advance preparation for emergency events that require assistance from the Disaster Airlift Response Team. The Board discussed assembling a welcoming committee for the visitors to KPAO.

Association Outreach Update

Charlie Brown then provided an update on the Association's community outreach and communications strategy. He discussed, among other things, creation of an airport newsletter, the proper content for such newsletter, and efforts to drive subscriptions to the newsletter in the airport community.

Upcoming Events

The Board then discussed the upcoming annual meeting on Tuesday, May 6th.

The Board then discussed scheduling the annual Airport Day event in September and considerations related to preparations for Airport Day.
